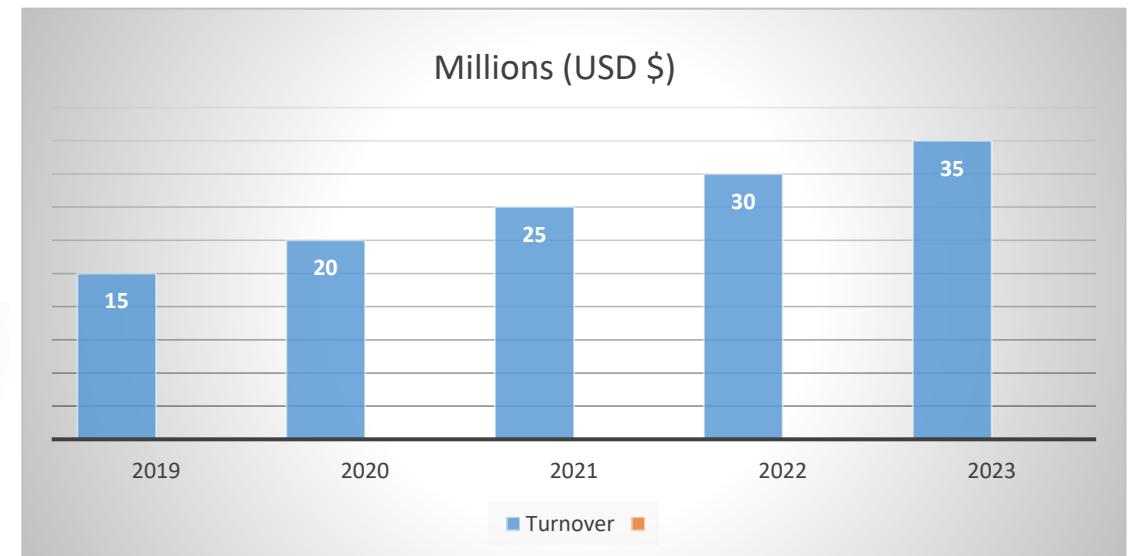
Journey from Zero to Hero

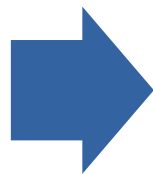


Our Products and Production Process:

Products:

- The Company is producing top quality garments for men, women and kids that are knit and woven . Galaxy Apparel Industry strictly follows the specifications and the appointed dates for the garments that are requested by our valued customers.

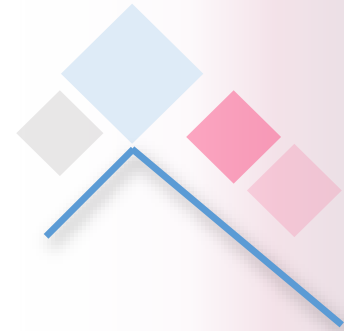
Our Production team arranged scientifically advanced equipment, techniques & manpower to achieve higher production with standard quality. While having conformation of a specific bulk order with shipment approval date, we deduce the fabric, raw materials and the trim arrival date, and make an action plan. Afterwards, we correspond to all related personnel to make their individual departmental plan.



Production instruction files are distributed to everyone related to the production process. There is a daily monitoring process to inspect whether the production is going per plan. In case it does not comply with the same steps, then a strategic plan will be carried out.



In case there are any kind of delays, the production progress is reported to the clients and if required to get an extension from them. Finally, we are providing external inspection if internal inspection is satisfactory. Shipping plan is taking place per pass report by internal and external audit.

Quality Process:

- We have several in-line, end-line and finishing quality assurance processes to ensure the quality of the garments. We follow 1.5%, 2.5% or 4% quality control standards to comply with the internationally established Accepted Quality Levels.
- We have separate quality control standards which are 1.5% for finished garments.
- Mandatorily, 10% of fabric and raw materials will be inspected before issuing for the line of operation.
- 100% of finished garments are inspected before packing to ensure that there are zero defects in packing. At present, we are introducing TQM to ensure 100% quality of our products to achieve the client's satisfaction.

Compliance and other facilities:

Compliance: The company complies with all the laws that are related to the labor welfare as stipulated by the government, the international labor organization and other recognized labor welfare organizations of the clients. The company also complies with the custom's laws and security regulations in place, as updated by the authority from time to time.

Accommodation: We have separate accommodations for male and female workers near the factory. All rooms are very spacious and tidy. We follow the Health Ministry's latest requirements. There are sufficient washrooms, toilets and water supplies and sufficient electricity supplies per seasonal demand. Fire alarms with firefighting equipment are also provided. Additionally, first aid kits with full ingredients are available at every floor of the dorm.

Social Security: This security setup is managed by The Social Security Corporation of the Jordan Ministry of Labor. It ensures the employees' insurance coverage if there are any unforeseen mishaps, including disability, death, injuries, unemployment and in maternity needs.

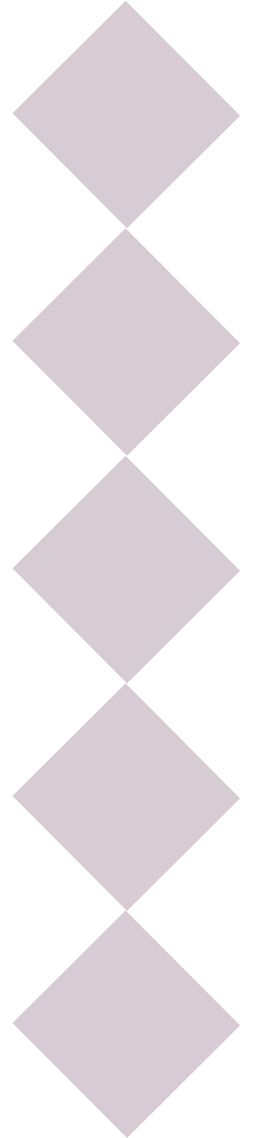

The minimum wages required by the local law, including mandated and overtime wages, all additional allowances are paid to our valued workers.

Working Hours:

Galaxy Apparel Industry ensures the working hours per day and the days per week do not exceed the legal maximum limit. One day off is allowed in every seven days, except if there is any emergency shipment pressure. In such cases, Galaxy is providing alternative/additional holidays as a compensation to workers.

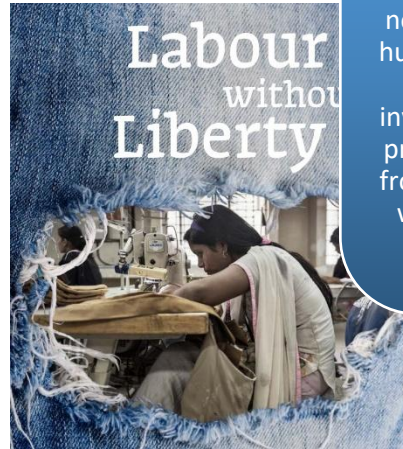


No Forced labor:
